Why we collect and process your data:

- <u>Contract</u> If you purchase something, we have a contract in place with you to deliver a product or service, for which we need to process your personal data in order to meet our contractual obligation.
- <u>Legitimate Interests</u> Where you have purchased from us or expressed interest in our products or services, we have a legitimate interest to communicate with you and hold your personal data. When processing under this basis, all data shared is safeguarded, relevant and limited to what is necessary and the parties' interests are balanced against necessary interests, rights and freedoms.

How and what information is collected about you:

We may collect the following information by email, telephone call, by post, digital forms, tracking cookies/analytics, or in-person:

- Name
- Email address
- Postal Address
- IP address
- Country/Location
- Any personal information you voluntarily submit on a form or during a video or telephone call.
- Photographs and videos, as required for delivery of services.
- Cookie data

What we do with the information we gather and what it is used for:

- Communication with you regarding purchases and/or to send you marketing material.
- Delivery/Provision of products and/or services.
- Business analysis and planning.
- Internal record keeping.
- Publishing material on our website and/or social media.

We will not sell, distribute or lease your personal information to third parties unless we have your explicit permission or are required by law to do so. Our employees, associates and agents may be given access to any Personal Information which we collect, but their use shall be limited to the performance of their duties and in line with the reason for processing. We may also store data with third party software providers for the purpose of business processing only, and these providers will be Data Processors by contract.

How we use cookies:

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site or page. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences. We may use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website to tailor it to customer needs. We only use this information for statistical analysis purposes.

Overall, cookies help us provide you with a better website by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us. We do not use cookie technology to collect Personal Information. However, we will endeavour to protect all Personal Information collected through our websites in accordance with our data protection standards.
